SUMMARY ANNUAL REPORT FOR THE AGMA RETIREMENT PLAN

May 31, 2020

This is a summary of the annual report for THE AGMA RETIREMENT PLAN, EIN 13-3826401, Plan No. 001, for period September 01, 2018 through August 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$3,213,037. These expenses included \$717,919 in administrative expenses, and \$2,495,118 in benefits paid to participants and beneficiaries. A total of 7,740 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$80,270,331 as of August 31, 2019, compared to \$75,653,788 as of September 01, 2018. During the plan year the plan experienced an increase in its net assets of \$4,616,543. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$7,829,580, including employer contributions of \$4,679,035, realized losses of (\$8,616) from the sale of assets, earnings from investments of \$3,156,865, and other income of \$2,296.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
