SUMMARY ANNUAL REPORT FOR THE AGMA HEALTH FUND

March 28, 2019

This is a summary of the annual report of the The AGMA Health Fund, EIN 13-2643045, Plan No. 501, for period September 01, 2017 through August 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has a contract with Aetna Life Insurance Company to pay health, dental and vision claims incurred under the terms of the plan. The total premiums paid for the plan year ending August 31, 2018 were \$5,587,711.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$14,701,226 as of August 31, 2018, compared to \$14,645,222 as of September 01, 2017. During the plan year the plan experienced an increase in its net assets of \$56,004. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$7,090,975, including employer contributions of \$6,247,544, employee contributions of \$475,474, realized losses of (\$23,179) from the sale of assets, earnings from investments of \$387,930, and other income of \$3,206.

Plan expenses were \$7,034,971. These expenses included \$798,040 in administrative expenses, and \$6,236,931 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
